Each Ranger we equip with essential gear, be that first aid kits, boots, mosquito nets or uniforms, builds morale and gives Rangers the tools they need for their often arduous patrols.

Each Family of a Fallen Ranger supported allows their children to stay in school, the family to keep a roof over their heads and perhaps set up a small business. Importantly, it sends a strong signal to the Ranger community that we have their back if the worst happens.

Each Ranger supported to attend meetings with their colleagues from around the world takes home vital information, shares their learning and builds morale

We know that there are many more Rangers and their families that need our support and we will strive to do more each year. We know that Rangers we have supported would tell us, "Keep going, this work has made a real difference to our lives and to our critical work'

Our heartfelt thank you to all our wonderful supporters: whether you are a first time giver, a monthly donor, a major philanthropist, a partnering organisation, an ambassador, a volunteer, Foundation staff or Director, or a Ranger doing the hard yards - we thank you!

THE SKILLS AND EFFORTS OF RANGERS ARE MOST NEEDED TO COMBAT SOME OF THE MAJOR **CHALLENGES** HUMANITY FACES

### **ORGANISATION OVERVIEW**

#### At the Thin Green Line Foundation, we recognise the unsung heroes of conservation - Rangers.

We believe that Rangers are the frontline defence for nature conservation. They defend our wildlife, wild places and cultural sites, often putting their own lives at risk to do so, yet their contributions often go unrecognised. Approximately 100 Rangers die each year in the line of duty, with little or no support for families after their passing. Many of these deaths result from a lack of adequate equipment or training and could therefore be avoided through strategic investment and intervention.


The Thin Green Line Foundation works with Ranger organisations, community enterprises and environmental NGOs to improve the livelihoods and working conditions of Rangers and their families globally. Through this work we increase community engagement in conservation, promote Indigenous and local knowledge within land management, improve the rights and recognition of Rangers, and support underfunded conservation projects worldwide.

## **MISSION**

**To Protect Natures Protectors. The Thin Green Line Foundation provides** vital support to Rangers, their families and communities who are the front-line of conservation.

### **VISION**

All Rangers, their families and their immediate communities around the globe are sufficiently supported to carry out their front-line conservation duties, and where a Ranger is injured or killed in the line of duty, the family is adequately supported.



# OUR FOUR PILLARS



#### **TRAIN**

We believe that competent, motivated and well-trained Rangers are crucial for effective nature conservation.

Unfortunately, research has shown around 40%\* of Rangers in Asia and Africa do not feel adequately trained to do their job – this ultimately affects their ability to protect wildlife, act in emergency situations and support their communities.

By investing in Ranger training we enable Rangers to fulfill their potential. We support Rangers to attend training courses and assist partners to develop bespoke training initiatives for their teams. We are also a founding partner of LEAD Ranger – a revolutionary "Train-the-Trainer" program in Africa which supports long-term development and professionalisation of Rangers.



### **EQUIP**

Around 60%\* of Rangers working in Africa and Asia lack the basic equipment to do their jobs effectively.

This limits their productivity, can lead to life threatening accidents occurring and reduces Ranger morale – ultimately to the detriment of conservation efforts. We want to ensure that all Rangers have access to the critical gear they need – keeping them safe and allowing them to conduct their role to the highest standards.

We support Rangers by funding vital equipment; from the basics like uniforms, water bottles and shelter, to tools that increase their capacity, like vehicles and GPS devices. We respect Rangers as the experts in the field and make sure that the equipment we fund is requested by the Rangers themselves. This ensures the tools are relevant to, and required by, those on the ground. It also shows respect for the knowledge and work undertaken by Rangers, boosting their selfconfidence and motivation.



## **EMERGENCY RESPONSE**

The role of a Ranger is dangerous – 82%\* of Rangers in Africa and Asia have experienced at least one life-threatening situation at work and, in the past ten years alone, over 1000 Rangers have died in the line of duty.

It is estimated that two-thirds of Rangers lack health insurance or a workplace pension – meaning that when the worst happens their families are left unsupported, often with no other family income.

Building the capability of
Rangers through training and
equipment provision can reduce
these numbers however, if the
worst should happen, our Fallen
Ranger Fund provides a financial
lifeline to the families of those
Rangers whose lives have been
lost while on duty. This work
extends to supporting family and
community emergencies, such as
medical expenses and relief for
natural and global crises.



#### CONNECT

Despite the crucial work they do to protect our natural world, Rangers are often under-paid, under-equipped and under-appreciated.

At the Thin Green Line
Foundation we work hard
to advocate for Rangers as
"nature's protectors" and
strive for Rangers to be seen
as respected conservation
influencers at local, national and
international levels.

We know that strong relations between Rangers and local communities are pivotal for effective conservation; so, we support projects that build positive relationships between communities, wildlife and Rangers. We also promote the Ranger profession at international events, connecting Rangers with decision makers and advocating for their role in nature conservation. Finally, we seek to connect Rangers with one another, encouraging skills and knowledge exchange which strengthens the profession globally.



Keeping Rangers at the Forefront of Conservation

in wildlife tourism
as an immediate
consequence of the
Coronavirus disease
(COVID-19) pandemic,
many protected areas
face reduced revenue
and budgets, which,
in turn, impacts staff
activity and vital
management services
including Ranger

patrols.

Since the beginning of the COVID-19 pandemic there have been many reports of increased poaching (both subsistence and commercial) and illegal resource extraction across many global regions. Reduced staffing and travel restrictions also severely impedes wildlife monitoring and control programs.

At the Thin Green Line
Foundation, we know that wellresourced Rangers working at
the forefront of conservation
have the skills and knowledge
to respond to the impacts of the
COVID-19 pandemic. That's why
we're applying for major funding
to urgently uphold our primary
mission: to provide direct and
ongoing support to Rangers.
Priority objectives of this
funding include:

- → Salary support (replacement wages or top-up pay) to ensure normal work cycles;
- → Essential personal equipment for patrols and other fieldwork;
- → Funds for medical treatment for Rangers diagnosed with COVID-19, and
- → Financial aid for the families of Rangers who have died from COVID-19.

Salary support will keep vital skills and knowledge where they are most needed, and sustain the invaluable experience required to protect endangered species, ensuring the livelihood of what is the most effective and irreplaceable conservation resource available – Rangers in the field.

For many years the Foundation has been kitting up Rangers with essential field equipment including waterproof shelters, mosquito nets, first-aid kits, and boots. This gear together with ration packs will enable Rangers to undertake their regular conservation fieldwork, including anti-poaching patrols. Close liaison with our partners on the ground - including the extensive International Ranger Federation network will ensure that the right equipment is distributed where it is most needed.

This support is scalable, and possibilities exist to build upon our partnerships with manufacturers and suppliers for even greater impact.

In parallel with this work, we have initiated a quarterly "Round Table" discussion with conservation organisations, funding bodies, Ranger advocates and, of course, Rangers themselves. Through these meetings we are developing opportunities to improve Ranger working conditions, secure sustainable funding revenues and raise the profile of Rangers globally. In providing this support to Rangers we are not only investing in their capabilities but, importantly, boosting their morale, enhancing their status in conservation strategies and, ultimately, strengthening their resolve to face a daunting challenge to fight for the world's wildlife.

#### **OVERVIEW**

Rangers need the knowledge to assess dangerous situations with people, wildlife, fire or flood. This knowledge underpins the judgement and decisionmaking required when choosing to intervene or to pursue, to know when to evade dangerous situations, or how to save the life of a wounded colleague.

We believe that investing in training for Rangers is an essential way to help protect nature's protectors. That's why in 2019-2020 The Thin Green Line Foundation supported training programs for 135 Rangers based in seven countries. This included introductory Ranger training for Maasai women in Kenya, antipoaching training for the Zambezi Elephant Fund, emergency firstaid modules for attendees of the World Ranger Congress, and our flagship LEAD Ranger program in Africa.



**Delivered** in partnership with **Ranger Campus** and the International **Anti-Poaching** Foundation (IAPF), our **LEAD** Ranger program is a "train the trainer" initiative that supports skills development and knowledge exchange among Rangers.

Since 2017, 71 Rangers from 13 organisations and four countries have been trained in LEAD Ranger 'Instructor' courses. Of these 71 Rangers, 14 were selected by merit to continue training as LEAD Rangers, developing skill in an additional ten learning modules ranging from field medicine and snakebite first aid, through to criminology, forensics and firefighting. These Rangers are now in turn training their colleagues across Africa, with a potential reach of over 1700

COVID-19 lockdown, 31 Rangers "Life Saver" course. Since this time, most trainers and training programs have been curtailed due to the effects of COVID-19, however LEAD Ranger trainers are still working within their teams across Africa and are well-placed

to continue informal training in the field. This supports the predetermined LEAD objective to recruit trainers from within the ranks of Field Rangers.

What's more, participants remain supported via online mentoring, while a new program structure and materials are currently in development.

This year LEAD Ranger has also achieved the first ever ISO 9001 accreditation for Ranger training globally. This brings the program one step closer to reaching its aim to build a worldwide network of protected area law enforcement professionals. The quality of these Rangers is already being put to the test and we are thrilled to report that participants have used their skills to save the lives of eight people (colleagues and community members) since their graduation.




**OVERVIEW** 

Around 60%\* of Rangers working in Africa and Asia lack the basic equipment to do their oftenhazardous job.

Our work aims to reduce this number by providing Rangers an opportunity to invest in the equipment they are in most need of - be that uniform, tools, first aid supplies or even food or salary supplements. This year, with the help of our generous supporters and donors, we have equipped a over 1300 Rangers through projects that include Ranger Care Box grants, in-kind uniform donations and front-line projects led by Ranger organisations in Ecuador, Indonesia and Zimbabwe.

#### **RANGER CARE BOX CASE STUDY**

In 2018 we initiated the Ranger Care Box program to address the basic equipment needs of Rangers; ensuring they have the capacity to protect wildlife and that they return home safely after every patrol. We understand that Rangers work in different terrain and climate, with different roles and conservation outcomes; therefore, each applicant has the freedom to tailor the equipment they receive from a Care Box to their local needs. By doing so, we guarantee their equipment is relevant and necessary, and also help to support developing economies by encouraging local procurement.

This year our Ranger Care Box program has gone from strength to strength with two funding

rounds resulting in the provision of equipment for a total of 998 Rangers, from 10 countries, across three continents. Equipment requested by these Rangers included uniform items, patrol equipment, health and safety supplies and overnight shelters. The most requested items were waterproof jackets and ponchos, followed by socks and water bottles - a stark reminder that the skilled people working on the frontlines of conservation often lack even the most basic equipment.

For Care Box recipient Rhino Fund Uganda, waterproof ponchos and torches were required to improve rhino protection at night and through Uganda's wet season. Similarly, Big Life Foundation, based in Kenya and Tanzania, requested funding for waterproof clothing

with torches and mosquito cream for every team member. These essential items not only keep Rangers safe from disease like malaria, but also help them do their jobs more efficiently, ultimately for the benefit of wildlife.

In South America the Association of Rangers of NOA-Argentina required jackets and jumpers for 12 rangers working in the Southern Andes throughout winter; while The Venezuelan Ranger Corps revitalised their surveillance and control activities through the procurement of 50 military grade patrol boots. In addition, within Asia, 80 Rangers working with Freeland Foundation (Thailand) received personal sleeping bags and hammocks - essential when conducting multi-day patrols of the Ta Phraya National Park.



#### **FALLEN RANGERS**

Since its inception, the Thin **Green Line Foundation has** supported the families of Rangers whose lives were lost in the line of duty.

Nothing can compensate for the death of a loved one, however during these difficult times the Fallen Ranger Fund provides a financial lifeline that supports families through unforeseen circumstances. These grants are often used to mitigate the financial strain of a funeral, support children's schooling or assist a spouse to start a microbusiness that provides them long-term financial stability.

Thanks to the generosity of our supporters in 2019-20, we have raised our Fallen Ranger grants from USD \$1500 to \$2000, allowing families more financial breathing space in their time of grief. In this year alone, we have supported 40 families across 14 countries through the loss of a loved one. The Thin Green Line Foundation is very grateful to our global network of partners who liaise with family members and help coordinate funding requests without unnecessary strain on those affected.

It's over a decade since we started this fund and sadly we still see regular fatalities. In the past ten years over 1000 Rangers have died in the line of duty. In 2019-2020 a reported 137 Rangers died while working, though we expect this number to be much higher. About one attributable to poachers, other illegal hunters, or militia.

Timber poachers were responsible for an increasing number of fatalities. Working in remote areas many Rangers died in motor vehicle accidents, drownings and also fighting fires. Four of these Rangers succumbed to COVID-19.

Each year, on 31st July, the global Ranger community and The Thin Green Line Foundation supporters recognise World Ranger Day. This is our opportunity to stand in remembrance of our Fallen Rangers, honouring their lives, contributions and sacrifices and celebrating the Rangers that continue to risk their lives on the frontline of conservation each day.

#### **OVERVIEW**

#### The Thin Green Line understands the risks Rangers face every day of their working lives.

Operating in remote areas and frequently alone, a Ranger's dedication and commitment often puts them at risk when they challenge those who threaten wildlife or the environment. With this appreciation of the associated danger and threats, a fundamental aspect of the Foundation's mission is to preserve lives among the global Ranger community by providing an Emergency Response.

Many of our projects aim to build capacity and capability amongst Rangers in order avoid unnecessary accidents however, tragic losses still occur.

In these times, we endeavour to provide financial assistance to the families of our Fallen Rangers.

Our dedication to this work began with the Fallen Ranger Fund but has grown in recent years to encompass a range of emergency situations. This year, through Emergency Response projects we have provided medical support for Ranger families, helped 40 families through the loss of a loved one and provided vital medical and accommodation support for Rangers and their families affected by the Australian bushfire crisis.

#### **FALLEN RANGER PROFILE**

Thai park Ranger Karn Chaiprasert, was leading a three-member patrol in Sap Lanka Wildlife Sanctuary when they spotted illegal hunters. Pursuing them deep into the forest, Karn was killed in an exchange of gunfire. An experienced Senior Ranger, Karn's death is utterly devastating to his family and colleagues who admired him for his courage and determination.

Danger is ever present for many rangers, and not just from poachers. Working in remote and wild places, there are countless risks to Rangers each working day. Emergency financial relief cannot truly compensate the family of a Fallen Ranger; however, it can alleviate pressures and help them find a new path to the future.

## THE JUNIOR RANGER PROGRAM CASE STUDY

Junior Ranger is a project that aims to connect people with nature by fostering respect and care for the natural world in children and linking them with the Rangers who work in their local protected areas.

Despite the unprecedented effects of the COVID-19 pandemic our Junior Ranger project has progressed with the development of a comprehensive framework and selection of three organisations to pilot education programs relevant to their local ecosystems.

Unfortunately, COVID-19 has delayed the implementation of these projects in the classroom, however the enthusiasm of our partners has not wavered. Staff are eagerly working to develop learning resources in anticipation of social distancing regulations being relaxed:

Mount Kenya Trust will use the Junior Ranger initiative to build on their existing environmental education program. They aim to develop learning materials that delve deeper into the conservation of Mount Kenya as a wildlife haven and as a vital source of water for the communities living around it.

Big Life Foundation will expand their existing education program by including local Maasai Rangers in teaching and field excursions to the Amboseli National Park. One of their ideas is to take their dog unit to local schools, demonstrating tracking techniques to teach children about Ranger skills.

Game Rangers International are developing resources that will train two full-time Conservation Education Rangers. GRI plan to conduct their program with both the Lusaka and Kafue National Park communities.

#### **OVERVIEW**

Strong relations
between Rangers and
local communities are
pivotal for effective
conservation – yet
local people are
frequently excluded
from programs or have
negative impressions of
nature due to humanwildlife conflicts.

Through our projects we aim to build bridges and challenge the growing global disconnect between people and nature. We see Rangers as agents of change and leaders in their communities with the capacity to teach locals how to respect and care for the environment, providing benefits both for themselves and wildlife.

Whether a key objective, or a secondary outcome, connecting Rangers with communities is a consideration of every project we invest in. Examples include the Sumatran Ranger Project, where Rangers and local people have worked together to plant 13000 saplings in a reforestation project, or the training of six Maasai women as Rangers with Big Life Foundation; which boosts the economy and keeps children in education for longer. In another exciting step for the Thin Green Line, this year we initiated a first of its kind international Junior Ranger program, beginning with three partner organisations in Africa.

#### **OVERVIEW**

'Connect' is also about bringing Rangers together to share their knowledge, skills and experiences. We believe this work is critical for developing solutions to the social, economic and environmental issues that affect Rangers globally; whilst also strengthening the Ranger profession and boosting their visibility within the wider conservation community.

This year we have supported 99 Rangers to attend international networking events including the Latin American and World Ranger Congress'. In the wake of the COVID-19 pandemic, we have also been at the forefront of connecting Rangers with international funding bodies, ensuring the voices of the people working to protect wildlife throughout this challenging time are resourced and respected\*.

## THE WORLD RANGER CONGRESS CASE STUDY

In November 2019, over 500 Rangers travelled to the village of Sauraha, on the border of Chitwan National Park, Nepal, to attend the 9th World Ranger Congress.

The Congress, held every three years, provides Rangers around the world a chance to collaborate and share skills; for many in attendance this is a once in a lifetime opportunity. What's more, this Congress was the first to be held in Asia; the largest event of its kind, with 500 Rangers attending; and the most diverse yet, with women making up 42% of participants.

Thanks to the generosity of our supporters, the Thin Green Line Foundation supported the travel and accommodation costs for 65 Rangers, and the registration costs of 74 Rangers. Without our support, many would not have the ability to attend such events, meaning opportunities to share knowledge would be missed and regional concerns would be underrepresented.

ALGETI NATIONAL PARK, GEORGIA

During the Congress, Rangers learned about conservation efforts to protect Critically Endangered species, like the Greater One-Horned Rhino, and many were given a unique opportunity to share their knowledge on an international platform. During the Congress, five Thin Green Line funded Rangers took to the stage and presented their work to the international Ranger community.

One such Ranger was Lusine
Dostibegiani, who presented


## FINANCIAL **STATEMENT**

In 2019-2020 we raised a total revenue of AUD\$1.72 million, with a remaining cash balance of \$1.76 million. Income has increased by 37% from the previous financial year. Money gifted from two bequests as well as funds donated by the general public comprised 90% of the foundation's income for the year.


General operating expenses remained comparable to last year, however, project funding increased by 56% year on year, totalling more than \$1.11 million. 39% of project expenditure went to *Training* Rangers, with the bulk going to the LEAD Ranger program. 34% of project funding went to Connecting Rangers (Pillar 4); this was largely made up of funding for sponsored rangers to attend the 9th World Ranger Congress in Nepal. The remaining 27% of project funding is split between *Emergency* Response projects (Pillar 3) and Equipping Rangers with critical tools (Pillar 2).

The Balance Sheet continues to be stable, with strong liquidity and large cash reserves. Some of the uniforms donated in 2016- 2017 (showing as Inventory) were distributed to the ground this year, with the remainder to be donated as needs are identified over the next financial year.
